

## 使用目的確認書

この度は、ATUM社ベクター製品にご興味をお持ちいただきまして誠にありがとうございます。本製品につきましては、ご購入前に以下の使用目的確認事項のご確認をお願いしております。各項目につきまして内容をご確認いただき、本書類にご署名をお願い致します。必ず直筆でご署名された書類を販売店にお渡しください。本確認書を弊社が受領した後に、ATUM社へ製品の発注を致しますので、予めご了承ください。

### 【使用目的確認事項】

#### 1. ATUM社 カタログ製品につきまして

By purchasing ATUM Catalog Products, the purchaser agrees these Catalog Products are for single laboratory/company use only, and not for clinical, diagnostic or therapeutic purposes, or for human consumption. Purchaser may not (1) modify the Catalog Products in any way, including without limitation by replacing any protein-encoding sequence with any other protein-encoding sequence; (2) determine the sequences of the Catalog Products; (3) disclose the sequences of any Catalog Products (including those for which ATUM provides the sequences); (4) directly or indirectly reverse-engineer the Catalog Products; (5) create any derivative(s) of the Catalog Products; or (6) copy the Catalog Products. If purchaser purchases an ATUM vector that is sold in a form intended for purchaser to clone purchaser genes into, purchaser is granted a limited, non-transferable, fully paid-up, non-exclusive right to clone into such vector which must be performed using a kit purchased from ATUM. The Catalog Products shall not be distributed to any other party without the prior written permission of ATUM. If purchaser purchases a Catalog Product (but excluding ATUM Research Use Only Vectors, ProteinPaintbox, Pichia Strains and Reagents), purchaser is granted a limited, non-transferable, fully paid-up, non-exclusive right to use said Catalog Product, including for the production of proteins and research, development and commercialization of such proteins derived from Catalog Products.

For clarity, for any and all ATUM Vectors (including ATUM Research Use Only Vectors), once purchaser's gene has been cloned into an ATUM Vector by ATUM, or by purchaser using a kit purchased from ATUM, purchaser may replicate the resulting plasmid. Purchaser may modify a purchaser's gene cloned into an ATUM Vector designed solely for propagation but not for expression of cloned sequences ("ATUM Cloning Vectors") in any way, including by replacing any protein-encoding sequence with any other protein-encoding sequence. Notwithstanding anything to the contrary, purchasers may transfer ATUM Cloning Vectors to any third party without the prior written permission of ATUM.

#### 2. ATUM社 Electra Vector につきまして

The purchase of ATUM Electra Vectors conveys to the purchaser the limited, non-transferable right to use only the purchased amount of the Electra Vector.

#### 3. ATUM社 研究用ベクター 品番 pD21xx, pD25xx, pD26xx, 34xx, pD35xx, 36xx, 37xx につきまして

Any product containing pD2100, pD2500, pD2600, 3400, pD3500, 3600 or 3700 series ATUM vectors, or an ATUM vector containing the FH8 solubility tag (the "Research Use Only Vectors") (including Electra vectors, vector configurations for expression of multiple genes and other customized configurations of the Research Use Only Vectors, and ProteinPaintbox genes or purchaser's genes cloned into the Research Use Only Vectors) is subject to a limited, non-transferable, non-sublicensable, non-exclusive license pursuant to which purchaser acknowledges and agrees that the Research Use Only Vector and any product containing a Research Use Only Vector may be used for internal research and development purposes only and may not be transferred to any third party under any circumstances (except with prior written authorization from ATUM) or used for commercial purposes. Use for commercial purposes, including any use in manufacturing a product or service that is provided to a third party, requires a separate commercial license from ATUM.
